BOWIE CITY COUNCILMAN TODD M. TURNER FILES FOR NOVEMBER CITY ELECTION

ANNOUNCES CANDIDANCY FOR AT-LARGE BOWIE CITY COUNCIL SEAT

Bowie, MD –Three-term Bowie City Councilmember Todd M. Turner, 43, was the first candidate to file this week for the Bowie City Election to be held on November 8, 2011. Councilmember Turner made good on his pledge he made last year to seek one of the two At-Large City Council seats.

“I am pleased to start my election campaign to earn the support of the citizens of the entire City of Bowie this November,” candidate Turner stated. “After my election in 2005 I promised to work hard every day for our residents, our families and our City, to be responsive to their concerns and issues, to involve the community in my and the City’s decision-making process, and to get the results we need. I believe I have lived up to my promise and I am seeking to bring my almost six years of experience, knowledge and successful work to represent the entire City in the At-Large position,” he continued.

Councilmember Turner was first elected in 2005 to represent the 3rd Council District and was re-elected in 2007 and 2009. He served as Mayor Pro Tem, the first African-American to hold the position in the City’s history, from 2007 to 2009. Prior to being on the City Council, he served in various positions in the City, including his former service as Co-Chair of the City’s Diversity Committee, as a member of the City’s Strategic Plan focus group, as former Secretary of the Citizens Association of South Bowie and past President of the Covington Recreation Association, a 1,100 home subdivision. Council Member Turner serves as the Council liaison to the Community Recreation Committee and the 1st Vice-Chair of the Washington Council of Government’s Transportation Planning Board, where he represents the City.

He, his wife, Anita Gauhar Turner, and their two daughters – Rachel and Maya - reside in the Longleaf section of Bowie.
